On Tuesday, July 16th the first cohort of participants in The Arc of Essex County's new vocational exploration and workplace readiness program completed their training. A partnership with Villa Restaurant Group, the six-week program provided participants the opportunity to learn the ins and outs of working in a restaurant with support from restaurant management and The Arc of Essex County's employment specialist.

Upon program completion and based on interest and skills learned, graduates have the opportunity to pursue career planning at a Villa location where they learn a specific role within the restaurant with one-on-one job coaching. One of the four original participants will continue to the career planning stage later this summer while the other three will move on to the next vocational focus area, horticulture. The Arc of Essex County looks forward to the second cohort of participants beginning in the fall!

## The Arc Receives 2 Grants

## for Camp Hope

The Novartis Corporation recently awarded The Arc of Essex County's Camp Hope a \$4,000 grant to provide financial assistance for children and young adults with intellectual and developmental disabilities to attend Camp Hope. Since 2007, Novartis has awarded The Arc of Essex County more than \$36,000 to offset camp tuition and fees for individuals and families in need.

The New Jersey State Golf Association (NJSGA) Youth Foundation also contributed a \$10,000 grant to enable The Arc of Essex County's Camp Hope to fund an adaptive sports specialist to craft and



implement a sports program each summer that engages campers of all abilities in varied sports activities. A position created in 2018 as a result of this three-year grant, the adaptive sports specialist helps campers realize their athletic potential and achieve goals in a variety of sporting activities.

Camp Hope is an eight week summer day camp for children and adults with intellectual and developmental disabilities located in East Hanover. Operating since 1956, camp runs Monday through Friday, 9 am to 3 pm, starting in late June and ending in August, with transportation provided for campers living in Essex County and surrounding areas. Camp Hope provides campers with traditional camp activities including supervised swimming and outdoor fun with modified sports, arts & crafts, and music. While enjoying these activities, attention is also given to daily living skills, peer interaction, socialization skills, and developing appropriate behaviors.



## **Leave a Legacy**

# Planned Giving with The Arc of Essex County

One way for you to support The Arc's mission is to leave a bequest. A bequest is a gift made to charity in your will or trust. One significant benefit of making a gift by bequest is that it allows you to continue to use the assets/property you may leave to charity during your life. Another benefit is that by making a



bequest you are able to leave a lasting legacy for the work of The Arc.

Once you know how you wish to include The Arc in your estate plans, contact The Arc of Essex County to confirm the correct organization name and address(which your attorney will need). Keep in mind that your gift can be for a specific amount, a percentage or some portion of the remainder (after family, relatives and friends have received their designated share). Below are examples of language you can use with the correct name and address of The Arc of Essex County (where you wish your gift directed).

#### **Types of Bequests**

There are a number of ways you can make a bequest to The Arc. You can leave what is called a specific bequest. A specific bequest involves making a gift of a defined dollar amount, a particular tangible asset such as real estate, a car, other property or even shares of stock. For example, you may wish to leave your home, a portion of its value or \$10,000 to The Arc of Essex County. Another kind of specific bequest involves leaving a percentage of your overall estate to charity.

There is also the option of a residual bequest. A residual bequest is a bequest that is made from the balance of an estate after the will or trust has given away each of the specific bequests. A common residual bequest involves leaving a percentage of the residue of the estate to charity. For example, you may wish to leave 30% of the remaining value of your estate to The Arc of Essex County.

#### **Bequest Benefits**

There are no limitations on bequest gifts. Bequests may be made for a general or specific purpose. All bequests to taxexempt entities approved by the IRS are not subject to estate taxes. Please be sure to consult your tax advisor for advice regarding your own personal situation. If you have a taxable estate, the estate tax charitable deduction may offset or eliminate estate taxes resulting in a larger inheritance for your heirs.

#### I Want to Learn More
