Fundraising Goal Exceeded at the 17th Annual Building Tomorrows 5K Run, 2-Mile Walk, and Family Fun Fest

n Saturday, April 25, more than 750 family members, friends, consumers, and advocates for The Arc of Essex County gathered in Bloomfield's Brookdale Park for the 17th Annual Building Tomorrows 5K Run, 2-Mile Walk, and Family Fun Fest featuring games, arts & crafts, face painting, and a bounce house, amongst other activities.

Affiliated with the New Jersey Step Up for The Arc initiative, this family-oriented event raises both awareness and funds to support dozens of programs and services offered by The Arc of Essex County to individuals with intellectual and developmental disabilities and their families. The total amount brought in, through registration fees, contributions, and sponsorships, exceeded expectations, totaling nearly \$82,000.

The attendees on this chilly, yet sunny April morning included The Arc's Chief Executive Officer, Linda C. Lucas, Board President, Brad Hopton, numerous members of The Arc's staff, hundreds of runners and walkers, volunteers, sponsor representatives, and five elected Student Ambassadors. Additionally, amongst the walkers, were program participants and group home residents of The Arc of Essex County, who were accompanied by program staff members.

Impressive run times were achieved by both the male and female 5K champions. Cody Kingman, 17, from Charlton, Mass., won both the men's division and the overall race with a time of 17:21. Jerika Lufrano, 14, from Montclair, N.J., won the woman's division with a time of 21:13.

In addition to outstanding fundraising

results by running and walking teams and individuals, more than \$55,000 of the total money raised was contributed by generous sponsors. Where are We in the Fee-For-Service Transition?

n the last issue of The Guardian we provided a brief overview of the New Jersey Division of Developmental Disabilities (DDD) fee-for-service transition, including the anticipated roll out beginning July 1, 2015. Much of the information providers, consumers, and their families wanted to know regarding next steps was not yet developed or unclear.

Since January, the DDD has issued a second draft of their Supports Program policy manual following concerns and comments voiced by provider organizations and stakeholders, including The Arc of Essex County. The DDD also revised the day habilitation rates that provider organizations can charge for services in the new model. Here is what we know so far:

- Service providers must be DDD and Medicaid approved to bill for services in the new model
- 2015 graduates will be the first group to transition to the feefor-service system, followed by individuals who entered adult services in the past three years
- Each individual will select a support coordinator to help guide them and their families in selecting services
- In order for DDD to assign rate tiers in the new system, each individual will be assessed using the NJCAT and DDRT to determine their current service needs

- Assessments will take place over the next few months
- The assessment results will determine each individual's rate tier and annual budget for services; with this budget in mind, individuals and their families can choose their services moving forward

The fee-for-service transition is an evolving process, with additional information and policies still forthcoming. For additional information and announcements regarding the DDD's transition, visit the fee-for-service implementation website below or email the Supports Program Help Desk:










Camp Hope Welcomes Campers and Changes

parking lot, nurse's office, two classrooms, and bathrooms, adding metal transition pieces to make the grounds more wheelchair-accessible. Another transition piece was installed at the pavilion entrance, near the camp pool. These enhancements were made in memory of Joseph Weitze and made possible thanks to the generous funding from Ellen Blumenkrantz and the family of long-time camper, Kelly Starrett.

The 2015 camp season features a variety of exciting activities for veteran and first-time campers alike. Some of the greatly-anticipated activities include the Fourth of July BBQ, Fossil Dig, Scavenger Hunt, Nature Walk, Talent Show, Carnival Day, and Outrageous Obstacle Course, amongst others. 
In Memory of Three Long-Time Residents and Day Program Participants



The Arc Kicks off the Parents' Workshop Series with Award Winning Author Natalie Hale

tepping Stones staff have been using the "Special Reads for Special Needs" curriculum to teach students how to read for a number of years. Thanks to funding from The Candle Lighters and The Arc of Essex County, the Stepping Stones education team and parents were able to learn directly from the curriculum developer, Natalie Hale, during a series of workshops at the Roseland campus in March.

During an all-day staff workshop on Friday, March 13, and a parent workshop on Saturday, March 14, Hale led attendees through an effective plan to teach reading to learners of any age with Down syndrome including current best practices, the optimal order of learning to read, sight word learning vs. Phonemic awareness, the Fast Flash method, and guidelines for creating personal books and adapting trade books.

The workshop was divided into two sessions, the first focusing on how to create personal books to aid in the learning process, and the second focusing on how to modify trade books to fit each child's learning needs. Parents and teachers left the workshops armed with the materials and plans to take their children's reading to the next level.

The Arc of Essex County continued the parents' workshop series with funding from The Candle Lighters on Tuesday, May 19, with presentations from The Arc of Essex County's Director of Business Development, Melissa Soules, Director of Education and Early Childhood, Sue Brand, and Director of Children and Family Services, Laurie Best. Soules, Brand, and Best discussed the different services and systems that families and children will experience throughout their life, including an overview of early intervention, the NJ Department of Children and Families, Children's System of Care, PerformCare, the transition years, and the Division of Developmental Disabilities.

The Candle Lighters 20th Annual Tricky Tray Raises More Than \$55,000



The Candle Lighters, a 501c3 organization dedicated to assisting the growth and well-being of children with intellectual and developmental disabilities by raising funds for The Arc of Essex County programs in need of financial support, hosted their 20th Annual Warm Your Heart Tricky Tray on Sunday, March 1. Raising more than \$55,000 and attracting approximately 450 people, the event was a rousing success.

Attendees tested their luck as they vied for 269 regular-sized prizes (valued up to \$100) and 107 large prizes (valued at amounts greater than \$100) which filled two rooms at the Mayfair Farms banquet hall in West Orange, N.J. By the time the ticket placement ended, many prizes had cups nearly overflowing. As a delicious four-course meal was served, tickets were pulled to pick the winners and results were announced by Tricky Tray Chairperson Stephanie Koprowski-McGowan, often to the energetic applause of the crowd.

To add to the excitement, there were three grand prizes: a \$500 Nordstrom gift card, a 50" Toshiba Flat Screen television, and

an Apple iPad. Additionally, three high-value ShopRite gift certificates, a Fair Share Raffle, a Lottery Scratch-off Apron (valued at \$100), and a \$500 Amazon gift card attracted excitement from attendees. To cap off the event, a Wine Cork Pull, in which each player wins a bottle of wine matching the numbered cork they picked, was very popular; this game alone raised \$1,030.

The tricky tray was made possible thanks to numerous supporters of The Candle Lighters, the Tricky Tray Committee, and dozens of volunteers who assisted in collecting basket prizes, wrapping baskets, and ensuring the smooth operations of the event. A number of local organizations generously donated their time to volunteer, including high school students from Oratory Preparatory School, Girl Scout Troop 38 from Assumption Church in Morristown, sorority sisters from Seton Hall University, as well as other friends and family of The Arc.

A few weeks later, in early March, Stepping Stones hosted members of The Arc of Essex County's staff and Stepping Stones family members for Read Across America.
