
Hundreds Attend 15th Annual Building Tomorrows 5K Run/2-Mile Walk

On Saturday, April 20, 2013 approximately 500 family members, friends, consumers, and advocates for The Arc of Essex County gathered in Bloomfield's Brookdale Park for the 15th Annual Building Tomorrows 5K Run/2-Mile Walk. This family-fun event is part of the New Jersey initiative known as Step Up for The Arc. Since 1999, annual runs and walks have been held by Arc chapters statewide, aiming to raise both awareness and funds to support programs and services provided for individuals with intellectual and developmental disabilities. This year, the event raised over \$52,000 through registration fees, contributions, and sponsorships.

The attendees on this brisk, sunny April morning included The Arc's President, Bruce Bird, Chief Executive Officer, Linda C. Lucas, 378 runners and walkers of all ages, several physical therapists, dozens of spectators, and several members of Livingston's Free Masons who, as our Community Sponsor, provided refreshments. Amongst the crowd of cheerful spectators were 38 residents of our group homes, accompanied by staff. An additional 35 volunteers were present from Prudential Investments, Bloomfield College, Bloomfield High School, a Gap clothing store, and other individuals.

This year, our Day Program staff developed a physical fitness program that culminated in a Fitness Walk on April 17, providing consumers

Volunteers help create gardens at five Group Homes

Gardens are taking root at five residential programs thanks to the efforts of volunteers.

Retired Associate Executive Director Al Ianacone planted gardens at four programs, Linden Apartments, Cedar Grove, Claremont and Ashwood, while Oakwood's garden was created by its residents and their families. Ianacone, a recent graduate of the Master Gardener's program at Rutgers Cooperative Extension of Passaic County, said the course requires students to perform community service and the gardens would be a great way to give back to his former employer, the community and enhance the lives of the residents.

"It leads to a lot of enjoyment in a variety of ways," Ianacone said. He is being assisted in the gardens by his classmate, Susan Langner of Clifton. The pair designed narrow planting beds to allow the residents to walk around the gardens with a watering can without the need of walking between or among the delicate plants. Each garden has a variety of tomatoes, herbs, cucumbers, eggplants and flowers. Ianacone expects harvesting to begin in July.

At the Oakwood Group Home, Program Manager Marie Joseph worked with the residents' families to create the garden after it became a topic of interest in the home.

"They always go by other homes and see gardens. Now they

have their own," Joseph said. She hopes the garden will be an opportunity for the residents to learn about plants and gain a greater sense of independence by growing some of their own food.

"They love it," Joseph said.

Blair Conley, the brother of resident Laurence Conley, helped prepare the soil and donated plants for the garden including strawberries, sweet basil, peppers, tomatoes, and rosemary.

Stepping Stones Celebrates its Class of 2013

During a touching ceremony on Tuesday June 18, the Stepping Stones community said congratulations and goodbye to its four newest graduates who are the Class of 2013.

The school's staff, fellow students and families filled the multipurpose room to watch Braden Hopton, Ryan Langston, David Rios & David Smeragliuolo Jr. receive their diplomas. The morning ceremony was the culmination of years of hard work by the graduates. Stephanie Hopton, Braden's mother, said her son and family received tremendous support from the school's staff and other families.

"I do not know where my family would be or where Braden would be without Stepping Stones," Hopton said. Braden and David Smeragliuolo first came to Stepping Stones for its Early Intervention program when they were infants. David Rios and Ryan began five years ago, the same time Stepping Stones Principal Sue Wilson came to the school.

"Every graduation is special, but this year holds a very special place in my heart since each of these children began their journey with me," Wilson said. "I have observed them grow and learn since pre-school. Seeing them reach this milestone is extremely fulfilling and heart-warming."

At the start of the ceremony, the graduates and continuing students sang *The Star-Spangled Banner*, accompanied by pianist and Stepping Students Graduate, Lisa Markey. The students also sang and danced to the songs *Do-Re-Mi* and *The Wizard of Oz*. During the awarding of diplomas, the delighted guests' smiles became wider, the tears became more noticeable, and the sound of applause filled the room.

"Leaving there (Stepping Stones) is one of the hardest things we have had to do," Hopton said. From day one to each student's graduation, the school's teachers and therapists

strive to provide their students with the "foundation for their future," explained Wilson. According to Wilson, teachers, therapists, assistants, and parents work collaboratively so that by age 8 most students acquire the knowledge, social skills, and independence needed to continue on both the educational and life journeys.

"They are invested in seeing the kids succeed," Hopton said of the staff at Stepping Stones. Hopton said the team effort helps the children gain confidence.

"It gave him the opportunity to be a leader and it fostered his independence," Hopton said. Every skill gained and the progress made at Stepping Stones is a milestone in the child's life, and prepares them for the next step, according to Hopton.

The graduation ceremony concluded with a heart-warming video and photos of the students. The video showed students learning yoga thanks to the efforts of Lori Silverman, an instructor who volunteered her time to work at the school. Following the video, a slideshow was played to highlight the children's activities and friendships made throughout the year.

Camp Hope Opens for its 57th Fun-Filled Summer

Camp Hope opened on July 1 with nearly 140 campers signed up for one of its seven fun-filled weeks.

Located in East Hanover, Camp Hope is a seven-week summer day camp for campers five years of age and up. Camp runs from 9 am to 3 pm, Monday through Friday between July 1st August 16th, 2013.

Under the direction of Camp Director Becky Ewert, Camp Hope offers a wide variety of activities for summer fun including: swimming, art, music, nature, and sports. Camp Hope also provides door to door transportation, a full time nurse, field trips, and special events.

This year, there are 27 campers between the ages of 5 and 12 who are served in a 1 staff to 3 camper ratio and 51 campers between the ages of 13 and 20 are served in a 1 staff to 5 camper ratio.

Camp Hope also has 37 adult campers through its ACE (Adult Camping Experience) Program. These campers, many who began coming to Camp Hope as children, are served in a 1 staff to 6 camper ratio and go out into the community once a week for activities and field trips.

This year, the camp also has 27 campers who need a 1 staff to 1 camper ratio.

There's also an academic program, Summer Day Program at Camp Hope, which is serving eight students from five school districts in Essex and Morris counties. This program is under the supervision of a certified teacher in special education and places a strong emphasis on life skills, socialization, peer interaction, and development of positive behaviors.

Annual Meeting

State Grant Funds Agency-Wide Skills Training

The Arc of Essex County is offering its employees a variety of training classes, thanks to a grant from the New Jersey Department of Labor and Workforce Development.

The Skills4Jersey Grant is designed to bolster employees and management skills to improve the company's economic viability and enhance employees' skills. The Arc of Essex County received \$75,200 which it's using to offer training at every level from direct care professionals to executive management.

All of the classes are designed to enhance the organization through elevating the skills of all staff. By making improvements to ourselves and our practices, we then improve the care, services, and environments provided to our consumers and families.

The Agency Leadership Group (ALG), which consists of the executive management and agency's directors, are participating in a Strategic Planning course. Under the guidance of an experienced corporate governance expert, the ALG is creating a new Strategic Plan for the agency that will guide it through the next three years as it transitions from a contract based service to the new fee-for-service system under the Medicaid Comprehensive Waiver. Many of these top tier managers are also participating in a website course, collaborating to develop a new online presence for the agency.

At the management level, courses such as Value Stream

Mapping and Performance Management will improve managers' ability to guide and develop the staff under their direction, increasing their efficiency and effectiveness. For Staff, there is a four-class training series including, Business Communication, Team Effectiveness, Customer Service, and Conflict Resolution, that will provide an improved work setting and climate. The content of the classes intertwine to improve functionality for the staff between consumers, their families, and each other.

Everyone can take advantage of computer training in the areas of Microsoft Word, Excel, and Access/Outlook. These classes, offered at the basic and intermediate level, will improve participants' skills in some of most widely used applications. These skills will help employees within the agency, one of the goals of the Skills4Jersey grant program.

The Sun Shines on the 1st Annual Fitness Walk

The weather was beautiful for The Arc of Essex County's Day Program's First Annual Fitness Walk. Over 100 consumers, from all the Day Programs, attended the event held at Orange Park on April 10, 2013 as a kick off to the 15th Annual Building Tomorrows 5K Run/2-Mile Walk.

The Activities Development Committee, consisting of assistant managers and consumers from the Day Programs develop department wide special events throughout the year for consumer participation. Since some of our Day Program consumers do not have the chance to attend the 5K Race, the committee proposed this event as an alternate opportunity for these consumers to feel part of the 5K event while improving their health and fitness.

The preparation began in January with walking activities geared towards helping individuals increase their length of time walking and speed. Since the groups started in the winter, the staff became creative in implementing training sessions during the bad weather. The goal was to build healthy lifestyle habits and ensure consistency. Each week, the participants began and ended each session with stretching exercises. The beginning training schedule emphasized the increase in the time spent walking each week. The groups started with a weekly walk at an easy pace and gradually increased the number of days along with the amount of time and the distance. Programs charted each consumer's progress during their training schedule. As the

Fitness Walk date approached, the staff concentrated on improving consumers' walking form to increase speed. Many of the consumers lost weight as the walking activity became routine and consumers increased their time and distance. They were very surprised when their clothes were fitting them better and in some cases became loose.

The event was set up to replicate the Building Tomorrows 5K Run/2-Mile Walk to provide the total experience. The consumers were not only given the opportunity to increase their health and fitness level by participating in a fun and social activity but they also acquired the skills needed to successfully compete in a race. Each individual was directed to register at the check in table, obtain a race number, and identify a start and finish point. Consumers, who were not able to participate in the walking event, stood on the sideline cheering on their

peers. Several parents also attended the Fitness Walk to cheer on their child.

Christopher Tanis from the SWOP program came in first place, Arnold Chery also from the SWOP program came in second place and Shosiul Ahmed from the Opportunity Zone program came in third place for the men's division. Frances Chan from the Livingston CRC program came in first place, Suhaila Ansair also from the Livingston CRC program came in second place and Claudia Hallock from the SWOP program came in third place for the women's division. After the race, each consumer was given a bottle of water and a healthy snack. A goodie bag was also offered with a medal, trophy and t-shirt. Roderick Russell, a consumer from the Community Link program, was our DJ and provided the musical entertainment. Games and relay races were also setup in the middle of the field to provide additional opportunities to win medals.

In addition to our goal of health and fitness, this event provided an opportunity for our consumers to compete in a friendly competition while socially engaging with their peers. They were able to visit and hang out with friends they do not have the opportunity to see daily. Each consumer enjoyed the event and many continued to wear their T-shirts and medals to the program for several days afterwards. Since this was such a huge success, the committee has already begun to plan next year's fitness walk.

Purchase of New Condo Set for Later this Year

The Arc of Essex County is under contract to purchase a two-bedroom condominium in West Orange this summer.

The townhouse-style condo purchase is being funded with \$265,000 in federal HOME funds from The County of Essex. The agency's Supportive Living Program will utilize the condo for residents who require only minimal supports to live independently. Renovations to the home's kitchen, HVAC system, as well as, the installation of a fire suppression system will be completed before the home is occupied.

West Orange Group Home Opens

The Arc of Essex County's newest group home opened its doors on June 26.

The single-family residence is now home to four men who each have their own bedroom and share two bathrooms, and other common areas. The residents will receive support from our staff, 24 hours a day, seven days a week.

The project was funded with \$503,000 federal HOME funds from The County of Essex. The agency completed \$170,000 in renovations to the home including the installations of an accessible bathroom and bedroom and fire suppression




system.

The Arc of Essex County operates 32 residential facilities throughout the

county that can accommodate up to 140 people and provides support services to additional locations through its Supportive Living Program.

Oakwood Group Home has a Renovated Bathroom

Renovations to the Oakwood Group Home bathroom are now complete. The project, funded by a \$10,000 grant from the Hyde and Watson Foundation, included a new power flush toilet, hand dryer, shower with a bench and handrail, sink and vanity, tile floor and the installation of GFI (ground fault interrupter) outlet.

Livingston Township Awards COAH funds for New Group Home

The Township of Livingston awarded a \$400,000 grant to The Arc of Essex County to help fund the creation of a new group home.

The Arc will use the grant to purchase a single-family residence in the township that will be home to up to four people. The agency is seeking additional funds from The County of Essex to fund renovations to the property including the construction of an accessible bedroom and bathroom. The county funds will come from the federally funded HOME program.

The renovations are anticipated to begin soon with the home ready for occupancy in the fourth quarter of 2013. This home will become the 25th residential facility operated by the agency.
